143. QUESTIONS AND REPRESENTATIONS FROM MEMBERS OF THE PUBLIC

Mr John Palombi referred to application 19/01896/OUT – Land North of Woodend Farm, Hatfield Road, Witham. He said that the Witham and Countryside Society was promoting a footpath/cycleway adjacent to the railway line from the new developments to the railway station which would ease congestion and air pollution. He referred to the Draft Local Plan which was promoting footpaths and cycleways in the garden communities and this should likewise apply to developments in the town.

The Chairman thanked Mr Palombi for his comments.

144. CLERK'S REPORT

Members were informed that details of the Temporary Road Closure for the Witham Boxing Day 5 Mile Race had been received. Members had no objections to this request.

It was reported that Essex County Council proposed to carry out carriageway reconstruction of Chess Lane, Witham. The work was programmed to start on Monday, 2nd December 2019 and would last three weeks. Residents have been advised to park elsewhere.

Members were informed that application 19/00953/FUL – 1 Wheaton Road, Witham would be considered by the Planning Committee on 19th December 2019. Councillor Mrs A. Kilmartin said that she would attend to give support to this application on behalf of the Town Council.¹

LAND NORTH OF WOODEND FARM, HATFIELD ROAD, WITHAM

Application for outline Planning Permission with all matters reserved – Up to 450 residential dwellings, commercial floor space, residential care home and day nursery with all associated access, servicing, parking, drainage infrastructure, landscaping, open space and utilities infrastructure.

The Chairman reminded Members that the developers had made a presentation to a Planning Applications & Transport Sub-Committee Meeting on 10th June 2019 as a result of which Members had raised a number of issues. A further meeting with the developers had been held on 19th August 2019 and was attended by the Leader of the Council, the Town Mayor and a Ward Member from Witham South.

Members discussed the implications to this outline planning application and new road layout.

RESOLVED That a letter be sent to Braintree District Council Planning Officers asking that they go back to the developers to negotiate an improved application on the following grounds –

- An assurance that there would be no damage to the trees and hedgerows,
- Clarification regarding the layby for lorries on the slip road,
- Assurance regarding the access to the farm at the bottom of the site,
- Whether there will sufficient capacity at the roundabout once the A12 is triple laned,
- A sustainable footpath/cycleway, not as part of the current road system, linking up the development with both its neighbour and the railway station,
- A logical bus route to go from one estate to the other.
