**Phase 4 Land North East of Rectory Lane, Witham** Enabling infrastructure for the NE Witham Phase 4 development (approved under 20/02060/OUT), including: a priority junction and revised site access off Rickstones Road; section of spine road restricted to bus, taxi and motorcycle use only; sustainable drainage system; landscaping; and, all associated development

Members agreed that the original decision to offer no objections subject to major concerns over the proposed design for the junction with Rickstones Road which will have limited access and egress by buses, taxis and motorcycles should stand.
